Gary Rutter reported that we currently have a balance of \$16,709.43. A motion was made to accept the treasurer's balance as read. All were in favor.

George Barrett reported that there been some grievance activity in Camden.

The fact-finding panel issued its' "Report and Recommendations" on April 30, 2019. The panel found that the "PFP system is broken and counterproductive" and they recommended that the "parties establish a joint work group to examine and report on the issues for career, non-bargaining-unit employees who are in field EAS positions. NAPS attended a meeting with the Rep. Jeff Van Drew. The meeting was scheduled for April 18 at 2pm. The meeting with Congressman Van Drew was successful. He has signed up for four of five resolutions. Thank you, Rob Hudson, for attending the meeting.

The State Convention will be held at the Resorts Casino & Hotel in Atlantic City, June 23-25, 2019 and Branch 74 will be funding an ad in the Journal at the cost of \$100. We will also be buying \$100 worth of raffle tickets and sponsoring a hospitality room for networking at the cost of \$75. There will be an election for State officials, the current slate will be running. Six members from our local branch will be attending the convention. Four members will be attending the grievance training that will be held on Sunday, June 23 at 11:00am. The cost for the training is \$30 per member and includes lunch.

Safety reported that there were two potential heat cases on May 20, 2019. The mandatory Heat Training is not a safety talk. There is a 20-30-minute Heat Stress Training for all employees. Enter the training in After the Fact Training in HERO. Don't discourage anyone from reporting an injury or accident.
